A. Introduction

- to any person in respect of whom we may reasonably be expected to have recourse to a court or other competent authority for the disclosure of personal information, provided that he has a reasonable opinion, such a court or authority would likely order the disclosure of such personal information.

Except as provided in this Privacy Statement, we will not share your personal information with third parties.

E. International data transmission

- We may store, process and transmit the information we collect between any countries in which we do business in order to use the information in accordance with this Privacy Statement.

I. Your rights

You can ask us to provide you with any personal information that is available to you about us; such information shall be provided under the following conditions:

1. proof of your identity in an appropriate manner for this purpose; we generally accept a photocopy of your passport, notarized, along with an original utility bill that includes your current address.

To the extent permitted by law, we may withhold the personal information you request. You can ask us at any time not to process your personal information for marketing purposes.
